- Providing goods and services to clubs and districts for their general activities
- Providing guidance to clubs and districts in their general activities and public relations efforts Communicating key organisational messages and information to district leaders and to clubs for dissemination at the club level

- Supporting THE ROTARIAN and the RIBI regional magazine "Rotary"
- Identifying Rotarians who have specific language and/or professional skills
